



## **Proposed Terms and Conditions**

### **ACS Social Media Campaign**

#### ***I. Ownership***

All images submitted must be the original work of the participant who must solely hold all intellectual property rights associated with the images submitted. Submitted images must not have been used for entry into other competitions or published elsewhere.

The participant grants the Association of Caribbean States (hereinafter "ACS"), and/ or other persons, or entities authorised by the ACS, license to use, publish, display and exhibit all original content submitted, in whole or in part, in its publications, brochures, and any other materials, as well as on its website and other online platforms, without cost or other obligation or restriction incumbent upon the entry.

The ACS will credit Participants when using their work.

#### ***II. Privacy***

The ACS will make every effort to respect the privacy rights of Participants. The ACS will maintain the confidentiality of all personal data submitted by the Participant in the course of entering this competition.

Participants agree that the ACS may use the personal information on their entry Google forms, insofar as it conforms to authorised use of personal data as prescribed by the Data Protection Act 2011.



The winning Participant/s consent/s to the use of his or her name/s attached to the use and display of the entry for crediting purposes by the ACS.

#### ***IV. Liabilities***

Participants indemnify the ACS against any claim relating to any damage, loss, injury or inconvenience or action of any kind resulting from the project, including those related to copyright or any other intellectual property right related to the entry.

The ACS will not be held responsible in any way for any violation of copyright or other intellectual property right related to the entry or any unauthorized use of the entry.

The ACS reserves the right to disqualify any entry if the contents are deemed inappropriate or deemed to be subject to competing intellectual property rights.

The Terms and Conditions above are subject to change and/or supplement by the ACS at any time. The ACS will make every effort to inform Participants of any change.

#### ***V. Governing Law***

This agreement shall be governed by the Laws of the Republic of Trinidad and Tobago. Any and all disputes related to this agreement shall be settled by negotiation under the laws of the Republic of Trinidad and Tobago, failing which all disputes shall be referred to the Dispute Resolution Centre of Trinidad and Tobago for arbitration.



## **Proposed Rules/Guidelines**

1. Participants must be a citizen of or currently residing in an ACS member state. See official ACS member states here: [Members and Associate Members | ACS-AEC](#)
2. Participants must be between ages 16 – 25 and currently enrolled in high school or University.
3. The photo can be taken with any kind of camera, whether it be a mobile phone or a professional camera.
4. Photo format can be any of the following: Landscape, Portrait or Square.
5. If the participant chooses to film a video, then the limit is one (1) minute.
6. The attached caption must not exceed 500 words.
7. Even if the participant submits a video, they are still required to also submit a written caption.
8. Participants are required to include or tag the location of the photo in the Google submission form and Instagram caption.
9. Participants are required to attach the tag #SaveourshorelinesACS to their Instagram post.
10. All photos submitted through the Google submission form must be a high-resolution digital image in the JPEG format. The image should not exceed 2MB in size.
11. No digital manipulation of the submitted photos is allowed and is grounds for disqualification.
12. Collages will not be accepted. One image per submission.
13. The submitted image must be an original work by the participant.
14. Staff and their immediate family members of the ACS and its affiliates are not eligible to participate in the contest.



15. The ACS reserves the right to disqualify any photo submission that does not conform to the rules and guidelines.
