2015-2024: Main international environmental negotiations on coats, seas and oceans

The Sustainable Development Goals Reports 2022:

Continuing ocean acidification and rising ocean temperatures are threatening marine species and negatively affecting marine ecosystem services. Between 2009 and 2018, the world lost about 14 per cent of coral reefs.

In 2021, more than 17 million metric tons of plastic entered the world's ocean, making up 85 per cent of marine litter. The volume of plastic pollution entering the ocean each year is expected to double or triple by 2040.

The global coverage of marine protected areas stood at 8 per cent of global coastal waters and oceans in 2021.

More than a third (35.4 per cent) of global fish stocks were overfished in 2019, up from 34.2 per cent in 2017 and 10 per cent in 1974. However, the rate of decline has recently slowed. Almost half a billion people depend at least partially on small-scale fisheries, which account for 90 per cent of employment in fisheries worldwide.



2015-2024: Main international environmental negotiations on coats, seas and oceans *With a global perspective*

2015: Sustainable Development Goals (mainly its Goal 14 and its 7 targets: marine pollution, management and protection of marine and coastal system, ocean acidification, overfishing, fisheries subsidies, benefits for sustainable use of marine resources in SIDS and LDCs).

2017-2024: <u>United Nations Conferences on Oceans</u> (I, 2017 –New York--, II, 2022 –previously arranged for 2020, was hold in 2020 in Portugal), III, 2024 –to be held in Costa Rica– and 2025 Niza, France.

2018-2023: Discussion and adoption of an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (pending to enter into force).

2015: Paris Agreement within United Nations Convention Framework on Climate Change (several discussion of effects from climate change and ways to reduce it on ocean is ongoing. It is related with the IPCC report on ocean, and Loss and Damages Fund)

2022: <u>United Nations Environmental Assembly 2nd Phase:</u>

Resolution 14: End plastic pollution: towards an international legally binding instrument (para 3... including in the marine environment)

August 20: should be released Zero Draft.

Resolution 5: Nature-based solutions for supporting sustainable development.

Intergovernmental consultations at regional and global level, october, 2023

2022: Kunming-Montreal Global Biodiversity Framework (adopted in Convention on Biological Diversity) (23 action oriented global targets for 2030 organized in three areas of work (in terms of implementation focus should be on Targets 2, 3, 8 y 11).

Ongoing: Intergovernmental Oceanography Commission

(to enable ocean science for addressing existential issues through of, among others: Ocean Decade Challenges –Pollutants, Ecosystems, Food from the Ocean, Ocean Economy, Ocean-Climate nexus, Ocean-related risks, Ocean observing system, ocean digital representation— and IOC work on Blue Carbon –The Blue Carbon Initiative, International Partnership for Blue Carbon and Global Ocean Decade Programme for Blue Carbon)








